4.3	The Client has already entered or will enter into a binding Agreement with Lobos Millonarios Capital by accepting the Service Agreement, which includes, <i>inter alia</i> , the Terms and Conditions, the Client Agreement and any attached Annexes, the 'Order Execution Policy' and any other documentation uploaded on the Firm's website, as from time to time amended by Lobos Millonarios Capital (collectively referred to 'Service Agreement').

5.1	The Client understands and accepts that the Representative shall be entitled to have the powers granted herein below, in accordance with the Service Agreement. Such revocation of the POA will become effective once received by the Back Office Department of Lobos Millonarios Capital, provided that the above mentioned conditions, are met. Revocation of this POA shall not relieve the Client of any liability which has arisen, for any transaction initiated prior to such revocation.
